Mounted Coconut Cup, the lid surmounted by a lion rampant

Coconut shell, mounted in copper and gilded silver; repoussé and engraved ornaments 210 x 95 x 125 mm (with handle)

on cover, lion rampant holding shield with the Remelinck family crest (Westfalia, c. 1630) sculpted thumb rest with sea nymph swan marks (on the rim of the lid, the rim of the base and on the lion's tail)

on the lid, marks "C H" and "C" (on the lion's head)

The swan mark was struck on silver articles imported to France from non-contracting countries in the period from 1893 until 1970. We may therefore assume that this tankard was imported to France in the late nineteenth or early twentieth century.

The personal papers found in Cornelius Gurlitt's Salzburg home include a collection of about 2,400 photographs of artworks. Photograph no. 21.1_F2101 is an interior shot of the Gurlitt family residence in Dusseldorf, with this work and other objects displayed on a cupboard.
