Note:

Friedrich Quiring (1886–1966), a retired army captain based in Eberswalde near Berlin, was a collector of old master drawings and prints. According to Lugt, Quiring owned important series by Altdorfer, Dürer, Rembrandt and van Ostade; the collector's stamp on verso is one that Quiring used until 1920 to mark his best sheets. Also per Lugt, Quiring is said to have sold some doubles, but no date for those sales is given.

Monika Gibas refers to sales in Berlin in the 1950s, but gives no details thereof. More recently, 150 old master works on paper from the Friedrich Quiring collection were sold through the Munich dealership Hartung and Hartung on 17 May 2001 (Auktion 102).
