#### Note:

The artist James Tissot (1836–1902) was Degas' friend and mentor in the 1860s and early 1870s. This drawing is a compositional study for the painting *Portrait of James-Jacques-Joseph Tissot*, now at the Metropolitan Museum of Art, New York (accession no. 39.161). The study on verso, a variant pose with legs extended, is related to another study for Tissot's portrait, now at Harvard Art Museums/Fogg Museum (object no. 1930.17).

According to the stamps on recto and verso, this drawing belonged to the estate of the artist, and was subsequently sold in 1918 or 1919 at one of a series of Degas' studio sales.

The first known owner of this work was the dentist Georges Viau (1855–1940 Paris), a well-known collector and patron of the arts. Viau began collecting at about the turn of the century and went on to assemble one of the largest private collections of Impressionist and Pre-Impressionist art in Paris. Sales of Viau works took place in 1907, 1909, 1925 and 1930, and posthumously in 1942, 1943 and 1948.

This work was acquired by Hildebrand Gurlitt, through André Schoeller, at the sale of Viau's estate in 1942 for the sum of 42,000 francs.

The personal papers found in Cornelius Gurlitt's Salzburg home include a collection of about 2,400 photographs of artworks. Photograph no. 7.1\_F702 is a reproduction of this work; inscribed on verso, a certificate of authenticity by André Schoeller of Paris, 13, Rue de Téhéran, dated 1 February 1943.
