#### Note:

The first known owner of this work was the composer and painter Jacques Zoubaloff (1876 Tiflis—1941 Neuilly-sur-Seine). A first sale of his collection took place in 1917, through Galerie Georges Petit. The two inscriptions on verso ("Georg(e) Paket") are a reference to that sale (probably a phonetic misspelling).

The work was subsequently owned by the dentist Georges Viau (1855–1940), a well-known collector and patron of the arts. Viau began collecting at about the turn of the century and went on to assemble one of the largest private collections of Impressionist and Pre-Impressionist art in Paris. Sales of Viau works took place in 1907, 1909, 1925 and 1930, and posthumously in 1942, 1943 and 1948.

This work was acquired by Hildebrand Gurlitt (through André Schoeller) at the sale of Viau's estate in 1942.
